Annotation:

Typical knowledge in the field of public communication is on the borderline of traditional sciences and includes conceptual and cognitive components of Sociology, Psychology, Social science, Anthropology, Journalism, Linguistics, Science studies and others. The heterogeneity of the subject involves study of a wide range of scientific and practical problems affecting the teaching of educational and scientific degree "PhD".

The main objective of the PhD program "Public Relations" is to realize a sustainable process of thorough research training of staff to acquire complex skills to competently carry out scientific and practical teaching in public communication.

To be considered successfully defended the thesis must receive at least three positive evaluations and each member of the jury publicly announces its evaluation.
