#### Annotation:

The discipline Drawing is a system of lections course and practical study tasks taken from the principles of artistic forms, perspective laws, plastic anatomy, technique - technological esthetics of expressive means. In that essence it is traditional and scientifically proven in fine art. At the same time it is also democratic because free content exercises are included in the program as well as introduction to the misteries of artistic drawing.

### Content of the study discipline:

During a gradual change and complication of study tasks in the study process students master practically laws and expressive means in order to build a drawing. A connection with other theoretical and practical discipline is build, such as painting, graphics, sculpture, decorative arts etc. Definition and analysis of the importance of individual elements in the composition and their meaning for the painting's finalization. Reaching of individual technical and esthetic results in the study process.

#### **Technology of study and assessment:**

The lections material is accompanied by practical exercise as the students fulfill tasks over arranged settings and certain artistical esthetic and thechnique – technological requirements. Demands for certification of a semester are regular attendance of lections and practical exercises, fulfillment of the posed tasks, number and quality of creations from outside of the auditory activity.

#### **Annotation:**

The "Painting" course provides a system of knowledge of the theory of painting as well as the necessary pictorial and imitative knowledgeable representational skills necessary for successful painting building.

### **Course content:**

This course provides knowledge about (i) the technology of painting , (ii) the composition , drawing , lighting and shading , (iii) color the spatial development of the specific nature of painting expression , (iv)proportions and sculpture of the head, clothed the naked human body, and (v) about building space by the laws of linear and aerial perspective.

**Technology of education and assessment**: Practical exercises set and individual tasks. The students master the different artistic painting's techniques and technologies. The applicable methods of presenting information are discussion talk, visualization (reproductions of artwork, student sketches), interpretation, evaluation, demonstration and corrections (with practical exercises).

**Evaluation, monitoring and permanent assessment**: At the end of 2nd and 3rd semester students do a practical exam. To form final assessment the results of ongoing monitoring different activities are added: painting portrait, landscape painting models, drawing color models, development of series of colored drawings related to the study material (human figure).

Annotation:

The brief lections course of perspective consists of the most basic fundamental minimum of knowledge on descriptive, projective and perspective geometry. That knowledge is necessary for the students in order to manage future professional tasks dealing with space, shape and light. The course is coordinated with the specifics of the subject to which it responds. As an addition to the theoretical part the minimum volume of practical exercise is included which is crucial for mastering the complicated problematic of perspective. Perspective as theoretical discipline is an inseparable part of the special /private/ theory of arts and is in close methodical connection with knowledge of painting, modeling, composition and history of art.

### Content of the study discipline:

Introduction to artistic perspective. History – theory. Essence of perspective as theoretical basis of plastic arts. Basic topics of perspective theory. Development of spacious images and genesis of perspective topics in history of art. Subjective and objective geometry of space. Projecting – classification and regularities. Orthogonal projection, trigonal system /3D/ - epur. Objects in trigonal system – point, line, plane, parallelepiped. Movement in the system – rotation, translation. Additional projection planes. Morphology. Sections, incisions – basic combinatory positions. Mutual penetration of edgy bodies. Covers in a 3D system. Conic sections. Rotational bodies – mutual penetration. Reading of orthogonal images. Stages in projection – groundplan, facades, side projections, incisions.

#### Technology of study and assessment:

The study process comprises of lections and practical exercise of perspective where the posed tasks for execution /drawing/ are constructive and come from the everyday visual practice. The executed elements and parts are predominantly architectural compositions: interiors, exteriors including terrains, buildings, vaults, arches, churches etc. Contemporary audio – visual means are used for visualization of the study process /aspectomat with diapositives, video techniques, movies and reproductions of artistic creations/. Necessary condition for mastering of the minimum knowledge is compulsory attendance of practical exercise.

#### **Course Outline:**

The course studies the essentials of the garment design process for industry needs: stages, requirements and output, "art design", the major steps in designing and modeling by type of garment. Introduced are the basic methods of rendering design ideas and some decorative techniques in garment making. This course provides opportunities for students to explore historical costumes, research current fashion styles and trends, analyze fibers and textiles, design clothing and accessories, utilize technology in fashion design. Students will be required to demonstrate creative use of inspiration and design experimentation through various projects.

**Learning Objectives:** To equip students with the necessary theoretical knowledge and practical skills for communicating design ideas, modeling and making various types of garments under specific requirements and approaches.

**Expected Results:** The students are expected to develop skills for artistic interpretation and application of theoretical knowledge in individual design projects for garments and accessories.

Lectures are supported by numerous examples and accompanied by demonstrations of selected techniques. Regular attendance of this course and demonstrated active learning are required for the completion of the semester.

Annotation: The purpose of the preparation of this course is for students to master the scientific bases of institutional organized training. It is important to develop their theoretical thinking, their ability to penetrate into the essence of didactic phenomena and processes, to analyze the legitimate links between tradition and innovation in education, navigate the changing pedagogical reality. Their attention will be offered to current theoretical issues and concepts arising from practice, the system of organized and targeted training in Bulgaria and the world. By modern interpretation of the problems students will be able to master thoroughly the nature, regularities, technology and training.

Content of the course: Scientific status of pedagogy. Personal development - biological and social factors. Role and importance of education and self-education. Family as an educational factor. Educational process. Methods, forms and principles of education. Didactics in the system of scientific knowledge. Learning as a comprehensive educational system. Didactic research and innovations. Learning process. Problem - evolving learning and the formation of higher intellectual skills. Content of the training. Theory of textbooks and academic literature. Principles of training. **Annotation:** 

The course is a brief introduction to information technologies. The goal of this course is to acquaint students with the fundamentals of information technologies and the media for communication with computers, namely, operating systems.

In the lectures, students will learn the main functions of information systems, software products for text editing, working with electronic spreadsheets, the significance and uses of databases and systems for database management.

In the exercises, students will gain practical skills for using software products for text management, electronic spreadsheets and database building and management systems.

#### **Course Content:**

Learning about operating systems, networks, searching skills in local and global network (Internet).

Text editing, automated spellcheck, working with templates such as business letters, projects, articles, etc. Working with images of various digital formats. Designing and creating databases, sorting, extracting and printing. Introducing students to some general aspects of mathematical movement modeling.

#### **Technology of Education and Grading:**

The course consists of lectures, exercises and independent out-of-class student work:

- 1. Classroom activities:
  - lectures on the main topics total of 15 hours;
  - exercises on pre-selected topics complementing the lecture material 15 hours.

Independent work with the main software; text editing; creating spreadsheets; Internet, etc.

*Methods of teaching*: Lecture, discussion, demonstration, visual aids (video , multimedia /reproductions , children's drawings, etc ./);

**Evaluation, monitoring, and permanent assessment**: At the end of 7th semester students graduate with permanent control evaluation. The students prepare (i) a course work on a selected topic of the study material; (ii) a special project design, and (iii) detailed analyze of bibliographical references.
