Annotation:

In the last decades because of many questions put in other fields of humanities and social sciences, historiography became one of the key and essential subjects in the departments of history all over the world. This course is directed towards post-graduate doctoral students who are trained with profile of historiography and other historical fields. It should provide them with knowledge about new trends in the development of the historical discipline, modern and contemporary historical schools in Europe and world-wide in the last two centuries. This program is not "philosophy of history" but "history of historiography". It is a follow-up of the course in historiography at the bachelor degree.

It is expected students to receive knowledge about the meaning of "historiography"; the development of history as a discipline, its object, methods, sources, methodological approaches, the changes in the idea of historical sources, the technics and narration of history etc. The PhD level course also provides comprehensive knowledge about schools, trends, circles, authors and grand-breaking research monographs. A special emphasize will be put on the developments in the historical disciplines in the last 3-4 decades – history of political culture, intellectual history, cultural history, micro-history, gender history etc.

Competencies of doctoral students:

Along with the formation of the required analytical capacity (when student comes to deal with empirical and theoretical research), this education degree seeks for another scientific economy, that is a longing for knowledge and concern with both the authenticity (of experience), and the (historical) truth, in order to build a new academic *habitus* of PhD graduates – scientific curiosity, courage for critical research, and historiographical passion.
